 - 2. <u>Vestibule Entry Doors</u>- Recommendation to approve handicap accessible bollards with buttons for automatic access, including ADA operators/actuators by Long Island Automatic Doors at a cost of \$23,230.00.
 - 3. <u>Projection Screens Upgrade</u>- Recommendation to approve projection screen in the Lecture Room to be upsized and upgraded for better movie-viewing capabilities in the amount of \$10,694.94.
